## **ORDER:**

The Government have been implementing the Prize Award Scheme from 1975 for Best Handloom Exporters of the State to encourage the export of handloom cloth in the State. The Scheme contain Trophies and Certificâtes.

2. In the Government Order first read above, the Prize Award Scheme for the Best Handloom Exporters was continued for a period of 3 years from 01.04.2017 to 31.03.2020 at an expenditure of Rs.1,00,000/- (Rupees one lakh only) per annum towards the expenditure.

3. In the letters second read above, the Director of Handlooms and Textiles has stated inter-alia that the Prize Award Scheme for the Best Handloom Exporters is much helpful to encourage the Handloom Exporters to increase the volume of their business and it appreciates their efforts taken to improve the export trade. Therefore, the Director of Handlooms and Textiles has requested the Government to extend the "Prize Award Scheme for Best Handloom Exporters" for a further period of three years from 01.04.2020 to 31.03.2023 and to sanction financial assistance of Rs.1,00,000/- per annum for 3 years from 01.04.2020 to 31.03.2023 towards the expenditure.

4. The Government after careful examination of the proposal of Director of Handlooms and Textiles decided to continue the "Prize Award Scheme for Best Handloom Exporters" for a further period of three years from 01.04.2020 to 31.03.2023 and to sanction a sum of Rs.1,00,000/- (Rupees One lakh only) per annum for 3 years from 01.04.2020 to 31.03.2023 towards expenditure for the implementation of the Prize Award Scheme for Best Handloom Exporters.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

"2851 - 00. Village and Small Industries - 103. Handloom Industries - State's Expenditure - AO. Relief to Handlooms Weavers - 359. Prizes and Awards.

6. The Commissioner of Handlooms and Textiles is authorized to draw and disburse the amount sanctioned in para 4 above. The scheme will be implemented by the Commissioner of Handlooms and Textiles in consultation with Handloom Export Promotion Council. In determining the value of prizes, the Commissioner of Handlooms and Textiles is requested to ensure that the awards which are in the form of Shields and Trophies are procured and distributed within the financial limit during the three year period and to ensure that there is no additional financial commitment on account of the Scheme and that the existing procedure with regard to the details of the Scheme will be scrupulously followed.


