**ABSTRACT**

ORDER:

In the Government letter first read above, among others, orders have been issued with policy directions and commitment letter to the Tamil Nadu Electricity Regulatory Commission providing for payment of subsidy for extending free supply to Handloom Consumers.

2. In the order 2nd read above, Hon'ble Tamil Nadu Electricity Regulatory Commission, provisionally approved and directed the Government of Tamil Nadu to release tariff subsidy for the FY 2021-22 for an amount of Rs.6.28 Crore for providing free supply of energy of 200 units bi-monthly to Handloom consumers as per the Policy Directions and Commitment given by the Government of Tamil Nadu.

3. In the letter 3rd read above, the Principal Secretary/ Chairman cum Managing Director, Tamil Nadu Generation and Distribution Corporation Limited has reported that as per section 65 of the Electricity Act, 2003, the Government has to release the tariff subsidy to TANGEDCO in advance for providing free supply of energy / reduction in tariff rates to various categories of consumers. Accordingly, the tariff subsidy for the 1st Half Year of the FY 2022-23 in respect of Handloom consumers has to be released by the Government on or before the date of commencement of the financial year. Similarly, the subsidies for the subsequent periods also have to be released in advance as per the schedule approved by the Hon'ble TNERC.

4. Considering the critical financial condition of TANGEDCO, and as per the provisions under Sections 65 and 108 of the Electricity Act, 2003, the Principal Secretary/ Chairman cum Managing Director, Tamil Nadu Generation and Distribution Corporation Limited has requested to sanction tariff subsidy of **Rs.3.14 Crore** (Rupees three crore and fourteen lakhs only) for the 1st half year of FY 2022-23 from 01.04.2022 to 30.09.2022 [@ 1/2 X Rs.6.28 Crore as per Hon'ble TNERC Order for FY 2021-22] for free supply of energy of 200 units bi-monthly to the handloom consumers, pending orders of the Hon'ble TNERC approving tariff subsidy payable for the FY 2022-23 so that TANGEDCO will continue to provide free supply of energy/ reduction in tariff rates and also requested that the payment of tariff subsidy may be exempted from the quarterly control of appropriation, if any.

5. The Government have examined the proposal of the Principal Secretary / Chairman cum Managing Director, Tamil Nadu Generation and Distribution Corporation Limited carefully and hereby accord sanction and release a sum of **Rs.3.14 Crore** (Rupees three crore and fourteen lakhs only) for the 1st half year of FY 2022-23 from 01.04.2022 to 30.09.2022 [@ 1/2 X Rs.6.28 Crore as per Hon'ble TNERC Order for FY 2021-22] for free supply of energy of 200 units bi-monthly to the handloom consumers, pending orders of the Hon'ble TNERC approving tariff subsidy payable for the FY 2022-23. The advance subsidy sanctioned above shall be made from existing provision under BE 2022-23 by relaxing QCA system for which orders were issued in G.O.(Ms.)No.97, Finance (BG-I) Department, dated 31.03.2022. Further, expenditure sanctioned above is exempted from QCA are included in the online QCA module of IFHRMS also, to facilitate drawal bills under IFHRMS as well so that TANGEDCO will continue to provide free supply of energy/ reduction in tariff rates.

6. The expenditure sanctioned in para 5 above shall be debited under the following head of account:-

“ 2851 - 00. Village and Small Industries - 103. Handloom Industries – State's Expenditure - AY. Payment to Tamil Nadu Electricity Board on behalf of Handloom weavers - 311. Subsidies - 01. Individual Based Subsidy”.

7. The amount sanctioned in para 5 above shall not be paid in cash, but shall be given to contra credit to the following head of account.

“K- Deposits and Advances (b) Deposits not bearing interest 8443-00 Civil Deposits 800 other Deposits –BM Deposits of Tamil Nadu Electricity Board 801 Receipts -02 Not Bearing Interest.”

8. The Director of Handlooms and Textiles, Chennai-108 is authorized to draw the amount of adjustments entry in the IFHRMS with reference to the amount sanctioned in para 5 above, in favour of the Personal Deposit Account of the Tamil Nadu Generation and Distribution Corporation Limited indicating

the Account Number 20210383614 the disburse the same to the Tamil Nadu Generation and Distribution Corporation Limited by remittance to the above credit head of account.
